Upon the death of a joint tenant, a surviving joint tenant must record a death certificate, and a notarized affidavit of joint tenancy, at the register of deeds in the county where the property is located. The death certificate must be a certified copy, and any person who was familiar with the joint tenant may complete the affidavit.

Joint Tenancy - An Affidavit of Death allows a surviving joint tenant to notify the title company and/or state of their husband's or wife's death and that title to property that the couple held in joint tenancy should be changed to reflect that the surviving spouse is now the sole owner of that property.
